WyoRINO SENATE BILL DESCRIPTIONS 2022

- HJ 05. Permanent Mineral Trust Fund- investments and distributions. This bill proposes an amendment to the Wyoming Constitution that would remove investment powers from the State Treasurer. The proposed amendment would require the State Treasurer to "credit" funds to a "separate earnings fund" rather than depositing funds into the General Fund. The newly created "separate earnings fund" would then be subject to complete control by the legislature. This bill passed the House, but was killed in the Senate 13-16-1. Its impact would have resulted in a violation of Wyoming Republican Party Platform/Plank # 10, violating the consent of the governed. We have assigned a plus to the NAY votes. https://wyoleg.gov/Legislation/2022/HJ0005
- 2. SF 09. Revenue bonds for agricultural endeavors. This bill authorizes the Wyoming Business Council to issue bonds, the revenue from which is to be used to fund private agricultural endeavors. This bill passed the Senate 17-13. Not only does this bill grow government, it also increases government's role in the economy in violation of Wyoming Republican Party Platform/ Plank # 9. We have assigned a plus to the NAY votes. https://wyoleg.gov/Legislation/2022/SF0009
- 3. SF 15. Oversize and overweight vehicles- fees and permits. This bill increases permit fees for oversize and overweight vehicles at a time when gasoline prices are skyrocketing to levels not seen in over a decade. Oversize and overweight vehicles often haul necessary commodities like vegetables, building supplies, or agricultural products. This bill, if passed, would have contributed further to record inflation. Luckily, this bill failed Senate introduction by a vote of 19-11. This bill violates Wyoming Republican Party Resolution Against Tax Increase, passed at the January 2019 WRP Central Committee Meeting. We have assigned a plus to the NAY votes. https://wyoleg.gov/Legislation/2022/SF0015
- 4. HB 31. Wyoming's tomorrow scholarship program. This bill creates yet another taxpayer funded scholarship program, this time for able-bodied adults in the state of Wyoming. Unfortunately, this bill was approved by the Senate by a vote of 16-14, and has been signed by the Governor. This bill grows the role of government, and violates Wyoming Republican Party Platform/Plank # 15, which states that all taxes collected must be used only for the constitutional purposes of government. We have assigned a plus to the NAY votes on this bill. https://wyoleg.gov/Legislation/2022/HB0031



- 5. SF 83. Prohibiting chemical abortions. This important bill would have banned the dangerous use of abortive drugs in the State of Wyoming. According to the Guttmacher Institute, chemical abortions make up over half the completed abortions in the United States. This bill passed the Senate 20-9-1, but was left to die in the House Speaker's desk. This bill supports Wyoming Republican Party Platform/Plank #1 as it stands for the protection of the unborn. We have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/SF0083
- 6. SF 94. Penalties for mandating COVID-19 vaccinations-2. This bill would have made it a crime for public officials both state and federal- to enact COVID-19 vaccination mandates. Unfortunately, this bill failed introduction in the Senate 7-23. This bill would have protected the rights of Wyoming citizens to control their health care decisions, and supports Wyoming Republican Party Resolution #1 Opposing Mandatory COVID Vaccinations in Wyoming, passed at the November 2021 WRP Central Committee Meeting. We have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/SF0094
- 7. HB 96. State officials salary. When inflation has hit record levels and the average household income in Wyoming is roughly \$64,000 per year, this bill increases the salaries of state officials. The salary of the governor is increased from \$105,000 per year to \$140,000 per year; the salaries of the secretary of state, auditor, treasurer, and superintendent eached climbed from \$92,000 per year to \$125,000 per year. HB 96 passed the Senate 11-18-1, increasing state salaries at a time when all other Wyomingites are being forced to tighten their belts, violating Wyoming Republican Party Platform/Plank # 15: all taxes collected must be used only for the constitutional purposes of government and never be more than necessary. We have assigned a plus to the NAY votes. https://wyoleg.gov/Legislation/2022/HB0096
- 8. SF 97. Change in party affiliation. This crucial bill would have prevented political party electors from changing party affiliation at the polls. This bill was approved by the Senate on third reading by a vote of 18-12, but was left to die in the House Speaker's desk. This bill addresses a longtime priority of the Wyoming Republican Party, supporting WRP Resolution #2, Resolution to Limit Voting Registration and Party Affiliation Changes up to but not on Election Day, passed at the november 2021 WRP Central Committee Meeting. We have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/SF0097



- 9. SF 103. Limitations on Teaching Critical Race Theory. This timely bill addresses the indoctrination of Wyoming's public school children. Under HB 97, Wyoming educators would be prohibited from teaching that America is rooted in "systemic racism." This bill makes clear that Wyoming teachers may not instruct students in the tenets of Critical Race Theory- a radical leftwing ideology rooted in Marxism and aimed at the destruction of America's founding values. This bill passed the Senate 25-4-1, but was never introduced in the House. This bill supports Wyoming Republican Party Platforms #s 10-13, as well as Resolution #7, Opposition to the Implementation of Critical Race Theory and the 1619 Project, passed at the November 2021 WRP Central Committee Meeting. Because of this, we have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/SF0103
- 10. SF 107. Attorney general-elected official. This bill would have changed Wyoming's attorney general from a governor-appointed position to an elected position. Such a change would serve to better protect the rights of Wyoming citizens, and would allow Wyoming voters to select the state's top attorney. Unfortunately, this bill failed introduction in the Senate 13-17. We have assigned a plus to the AYE votes because this bill supports Wyoming Republican Party Platform/ Plank #10: the best government is one which derives its power from the people. https://wyoleg.gov/Legislation/2022/SF0107

WyoRINO House Bill Descriptions 2022

- 1. HB 1 H2003. State Treasurer Budget Amendment. This amendment would have corrected the egregious work of the Joint Appropriations Committee in stripping the State Treasurer of constitutionally prescribed investment duties- all through a footnote to the budget bill. This amendment attempted to restore investment power to the State Treasurer, one of Wyoming's five statewide elected officials. Unfortunately, this amendment failed in the House by a vote of 27-32-1. This amendment supports Wyoming Republican Party Platform/Plank # 10: Wyoming voters elected the State Treasurer to invest funds, and the Joint Appropriations Committee passed this function to an unelected bureaucrat. - 2. HJ 03. Runoff elections-constitutional amendment. This bill would have paved the way to changing Wyoming's elections for the better by ensuring that those who govern the state earn a true majority of the votes cast. If passed, HJ 03 would have proposed an Amendment to Wyoming's Constitution establishing a May primary runoff election. Wyoming residents would have had the opportunity at the polls to approve this amendment at the next general election. The resolution failed introduction in the House 29-30-1. This resolution supports Wyoming Republican Party Resolution #3, passed at the November 2021 WRP Central Committee Meeting. We have assigned a plus to the AYE votes. <u>https://wyoleg.gov/Legislation/2022/HJ0003</u>
- 3. HB 23. Agriculture land qualifications-annual gross revenues. This bill would have increased the amount of property taxes paid by an untold number of Wyoming residents by changing the statutory meaning of "agricultural land" under Wyoming law. HB 23 attempted to require landowners seeking agricultural land status to prove \$5,000 in annual agriculture-related revenues, drastically increasing the current amount of \$500. Thankfully, this bill failed introduction in the House 34-25-1. We have assigned a plus to the NAY votes because this bill violates Wyoming Republican Party Platform/Plank # 15, which states that all taxes collected must be used only for the constitutional purposes of government and never be more than necessary. https://wyoleg.gov/Legislation/2022/HB0023
- 4. **HB 31. Wyoming's tomorrow scholarship program.** This bill creates yet another taxpayer funded scholarship program, this time for able-bodied adults in the state of Wyoming. Unfortunately, this bill was approved by the House of Representatives 49-10-1 and the Senate, and has been signed by the Governor. This bill grows the role of government, and violates Wyoming Republican Party Platform/Plank *#* 15, which states that all taxes collected must be used only for the constitutional purposes of government. We have assigned a plus to the NAY votes on this bill. https://wyoleg.gov/Legislation/2022/HB0031



- 5. **HB 35. County optional real estate tax.** This bill would have empowered Wyoming counties with the ability to impose a new excise tax- to be paid by the purchaser- on the sale of real property, further increasing the cost of real estate in Wyoming. This bill failed introduction in the House by a vote of 19-40-1. This bill violates Wyoming Republican Party Platform/Plank # 15 and Resolution Against Tax Increase, passed at the January 2019 WRP Central Committee Meeting. We have assigned a plus to the NAY votes. https://wyoleg.gov/Legislation/2022/HB0035
- 6. HB 40. Judges- housing allowance. This bill would have provided financial housing assistance to Wyoming Supreme Court justices and judges residing in counties where the average cost of housing is "significantly higher" than the statewide average. The bill's language is intentionally vague, and if passed, would have allowed for the expenditure of an unspecified amount of taxpayer dollars in excess of the salaries of these officials. Thankfully, this bill failed introduction in the House 37-23. We have assigned a plus to the NAY votes, as this bill violates the Wyoming Republican Party Platform/Plank # 15: all taxes collected must be used only for the constitutional purposes of government and never be more than necessary. https://wyoleg.gov/Legislation/2022/HB0040
- 7. HB 93. Wyoming film production incentives program. This bill would have created a new bureaucracy aimed at luring filmmakers to produce in Wyoming. The bait? Taxpayer dollars. Luckily, the House chose not to introduce this bill by a vote of 32-28. We have assigned a plus to the NAY votes. This bill violates Wyoming Republican Party Platform/Planks # 9 and 15, as it invites government interference in the economy. https://wyoleg.gov/Legislation/2022/HB0093
- 8. HB 96. State officials salary. When inflation has hit record levels and the average household income in Wyoming is roughly \$64,000 per year, this bill increases the salaries of state officials. Unfortunately, this bill died upon introduction in the House by a vote of 35-24-1. This bill supports Wyoming Republican Party's Platform/Planks # 10-13, as well as Resolution # 7, Opposition to the Implementation of Critical Race Theory and the 1619 Project, passed at the November 2021 WRP Central Committee Meeting. Because of this, we have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/HB0097
- 10. HB 118. Prohibiting mask discrimination for COVID-19. This bill makes it a crime for public accommodations to refuse services, goods, or facilities to individuals on the basis of refusal to wear a mask, and protects the personal autonomy of Wyoming residents faced with unconstitutional mask mandates. Sadly, this bill failed introduction in the House by a vote of 23-36-1. HB 118 supports Wyoming Republican Party Resolution # 6 opposing mask mandates, passed at the November 2021 WRP Central Committee Meeting. We have assigned a plus to the AYE votes. https://wyoleg.gov/Legislation/2022/HB0118
