SENATE BILL DESCRIPTIONS 2024

1. **SF0039. Firefighters recruitment film.**

This bill would have spent \$150K to hire a filmmaker to make a short film in order to encourage volunteer firefighters to serve in Wyoming.

It was defeated on introduction to the Senate, and constituted a wasteful and flippant use of taxpayer dollars. This bill violates WRP Platform Plank # 17, which states that all taxes collected must be used for the constitutional purposes of government. **We have assigned a plus to the NAY votes.** <https://www.wyoleg.gov/Legislation/2024/SF0039>

2. **SF0051. Unlawful dissemination of misleading synthetic media.**

This bill would have made it a crime to create or share “misleading” computer-generated speech, clearly violating the First Amendment to the U.S. Constitution and Article 1 Section 20 of the Wyoming Constitution. This bill also violates WRP Platform Plank #22, which states that free citizens must be able to express their beliefs– misleading or not– without government retaliation. Thankfully, this dangerous bill was killed in the House Corporations Committee. **We have assigned a plus to the NAY votes.** <https://www.wyoleg.gov/Legislation/2024/SF0051>

3. **SF0101. Low-carbon energy standards- repeal.**

This bill would have repealed industry-killing low-carbon energy standards that make it more expensive and burdensome to produce Wyoming energy. Unfortunately, this bill was killed on introduction in the Senate.

This bill supports WRP Platform Plank #11, which argues that the government must not unduly interfere in the free market. It also supports WRP Resolution on Oil, Gas, Coal, and other Power Policies adopted at the 2022 WRP State Convention, declaring that carbon “should be managed by producers of energy or the private sector and not the government.” **We have assigned a plus to the AYE votes.** <https://www.wyoleg.gov/Legislation/2024/SF0101>

4. **HB0125. Repeal gun free zones and preemption amendments.**

This bill would have gotten rid of gun free zones in Wyoming, enshrining Constitutional Carry as the law of the State in public places. This bill was successfully ushered through the Legislature but vetoed by Governor Gordon.

This bill supports WRP Platform Plank #3, which states that the right of individuals to keep and bear arms *shall not be infringed, restricted, or denied*. This bill also supports WRP Resolution calling on Wyoming to become a Second Amendment Sanctuary State adopted at the WRP State Central Committee meeting in May 2021. **We have assigned a plus to the AYE votes.**

5. **HB0148. Regulation of abortions.**

This bill would have required surgical abortion centers to be licensed by the State of Wyoming, which would have ended with the lone abortion provider in Wyoming closing its doors.

It passed with flying colors in the Wyoming Legislature, but was vetoed by Governor Gordon. Because this bill supports the #1 Plank of the WRP Platform, **we have assigned a plus to the AYE votes.** <https://www.wyoleg.gov/Legislation/2024/HB0148>

6. **HB0001. General government appropriations.**

This bill constitutes the biennial budget for the State of Wyoming, and as passed, was the largest budget ever adopted by the Wyoming Legislature. Filled with funding for projects and departments that do not fulfill constitutional functions of government, this bill violates WRP Platform Planks #11 (government must not interfere with the free market) and #17 (all taxes collected must be used for the constitutional purposes of government). **We have assigned a plus to the NAY votes.** <https://www.wyoleg.gov/Legislation/2024/HB0001>

7. **HB0001S3014. Third Reading Amendment #14 to the Budget Bill.**

This budget amendment would have defunded the University of Wyoming office of “Diversity, Equity & Inclusion,” an office and ideology which prioritizes groups of individuals on the basis of sexual orientation, race, ethnicity, and other characteristics. Not only are these programs unnecessary, they also openly discriminate against certain groups. (Cont.)

This amendment supports WRP Platform Plank #17, which states that all taxes collected must be used for the constitutional purposes of government. This amendment was successful, but Governor Gordon exercised his line-item veto power to remove it from the final budget. **We have assigned a plus to the AYE votes.** <https://wyoleg.gov/2024/Amends/SF0001S3014.pdf>

8. **HB0001S3061. Third Reading Amendment #61 to the Budget Bill.**

This budget amendment would have spent \$ 8 million on government-housing projects to “attract, retain and expand Wyoming’s workforce.” In seeking to meddle in the economy *and* expend funds for unconstitutional purposes, this amendment violates WRP Platform Planks #11 (government must not interfere with the free market) and #17 (all taxes collected must be used for the constitutional purposes of government). Luckily, this amendment failed 14-17. **We have assigned a plus to the NAY votes.** <https://wyoleg.gov/2024/Amends/SF0001S3061.pdf>

9. **HB0001S3021. Third Reading Amendment #21 to the Budget Bill.**

This budget amendment removed \$2 million from the Wyoming Business Council, a government agency which picks winners and losers in the private sector by propping up enterprises to compete with privately owned, small Wyoming businesses. This amendment violates WRP Platform Planks #11 (government must not interfere with the free market) and #17 (all taxes collected must be used for the constitutional purposes of government).

This amendment was adopted by the Senate, but was removed in the final version of the budget. **We have assigned a plus to the AYE votes.** <https://wyoleg.gov/2024/Amends/SF0001S3021.pdf>

10. **HB0001S3053. Third Reading Amendment #53 to the Budget Bill.**

This budget amendment removed 42 *vacant* full-time positions from the Executive Branch of Wyoming government. As these vacancies have existed for years and state government has not fallen apart, the positions are clearly not necessary. This amendment was successfully adopted by the Senate. *(Cont.)*

Because this amendment supports WRP Platform Plan #17 on taxing and spending, **we have assigned a plus to the AYE votes.** <https://wyoleg.gov/2024/Amends/SFO001S3053.pdf>

HOUSE BILL DESCRIPTIONS 2024

1. **HB0002. Nonresident fishing license fee increase.**

This bill would have bumped the prices of all nonresident fishing licenses, nickel-and-diming out of state recreators in order to grow government. Annual license fees would have climbed to \$110, daily license fees would have increased to \$14, and 5-day licenses would have become \$60. As all Republicans know, fee increases are tax increases.

This bill was killed on introduction in the Wyoming House, and for good reason, as it would have contributed to inflation and clearly violates WRP Resolution Against Tax Increases, adopted at the May 2021 WRP Central Committee Meeting. **We have assigned a plus to the NAY votes.**

2. **HB0017. Fishing outfitters and guides- registration of fishing boats.**

This bill would have empowered the Wyoming Game & Fish Commission to regulate commercial fishing guides in Wyoming, picking winners and losers, creating barriers to entry, and worsening inflationary pressures on private enterprise. Disturbingly, the bill language left the regulation of these businesses undefined, which would likely have resulted in runaway fees, burdensome registration requirements, and more.

This bill was defeated on introduction in the Wyoming House. Placing regulations on small Wyoming businesses and interfering in the market, this bill violates WRP Platform Plank # 11, which declares that the free-market economy is necessary to personal freedom and constitutional government. **We have assigned a plus to the NAY votes.** <https://www.wyoleg.gov/Legislation/2024/HB0017>

3. **HB0039. Campaign reporting.**

This bill would have dramatically expanded the number of individuals subject to Wyoming campaign finance regulations and penalties by requiring that any two individuals who spend more than \$1,00000 of their hard-earned money in any election report their activities to the State.

This bill violates WRP Platform Plank # 22, which states that freedom of speech, as a fundamental right, includes freedom to express beliefs *without fear of retaliation* by government. This bill was defeated on introduction in the Wyoming House. **We have assigned a plus to the NAY votes.**

4. **HB0044. Parental rights in minor child's health care.**

This bill would have repealed a provision of state law allowing the government to vaccinate Wyoming children without parental consent or knowledge during declared “public health emergencies.”

This bill was killed by the House Labor, Health & Social Services Committee. An attempt was made to revive it on the House Floor.. **We have assigned a plus to the AYE votes** on that motion, because this bill supports WRP Resolution Supporting Parental or Legal Guardian Rights, adopted at the 2022 WRP State Convention. It also supports WRP Platform Plan #10, which states that no medical procedure should ever be mandated under any circumstances.

5. **HB0053.**

This bill would have amended state law to require Legislative approval when and if the Governor seeks to declare and extend public health emergencies. When declared, these states of emergency threaten private property rights, religious freedom, rule of law, free speech, and countless other liberties as celebrated by nearly every plank of the WRP Platform.

This bill was defeated on introduction to the Wyoming House. **We have assigned a plus to the AYE votes.** <https://www.wyoleg.gov/Legislation/2024/HB0053>

6. **HB0148. Regulation of abortions.**

This bill would have required surgical abortion centers to be licensed by the State of Wyoming, which would have ended with the lone abortion provider in Wyoming closing its doors.

It passed with flying colors in the Wyoming Legislature, but was vetoed by Governor Gordon. Because this bill supports the #1 Plank of the WRP Platform, **we have assigned a plus to the AYE votes.** <https://www.wyoleg.gov/Legislation/2024/HB0148>

7. **SF0102. Foreign property ownership- critical infrastructure.**

This bill would have prevented dangerous enemies of the United States from owning land near military installations and other important, critical infrastructure sites in Wyoming.

This bill supports two WRP Resolutions adopted at the 2022 WRP State Convention (Defending Against Hostile Nations & Foreign Government Ownership of Land). After it was killed by the House Appropriations Committee, an attempt was made to revive it on the House Floor, which was unsuccessful.. **We have assigned a plus to the AYE votes** on that motion. <https://www.wyoleg.gov/Legislation/2024/SF0102>

8. **SF0120. Driver's licenses- unauthorized alien restrictions.**

This bill would have prevented illegal aliens from using government-issued photo ID to vote in Wyoming elections.

This bill supports WRP Platform Plank #23, which states that “the integrity of our elections must be upheld.” After being killed by the House Corporations Committee, an attempt was made to revive it on the House Floor, which was unsuccessful.. **We have assigned a plus to the AYE votes** on that motion.

9. **HB0001. General government appropriations.**

This budget amendment violates WRP Platform Plank # 17, which states that all taxes collected must be used for the constitutional purposes of government, as well as WRP Resolution supporting Protection of Minors from Gender Transition Treatments adopted at the 2022 WRP State Convention.
